

### Upcoming Changes to Central Health Medicare Plan's Formulary

Central Health Medicare Plan may add or remove drugs from our formulary during the year. If we remove drugs from our formulary we will notify you of the change at least 60 days before the date that the change becomes effective; unless the Food and Drug Administration deems a drug on our formulary to be unsafe or the drug's manufacturer removes the drug from the market, in which case we will immediately remove the drug from our formulary and provide retrospective notice.
